## FIRST ANNOUNCEMENT AND CALL FOR PAPERS

## **GENERAL INFORMATION**

The European Technical Centre of the international Information System on Occupational Exposure (ISOE) in collaboration with Temelin and Dukovany NPPs and the Czeck State Office for Nuclear Safety (SÚJB) is organizing the 2012 ISOE European Symposium on Occupational Exposure Management at Nuclear Facilities.

The Symposium will be held in **Prague, Czech Republic**, from 20<sup>th</sup> to 22<sup>nd</sup> June 2012. The OECD Nuclear Energy Agency (NEA) and the International Atomic Energy Agency (IAEA) cosponsor this Symposium.



## TARGET AUDIENCE

The Symposium is targeted at all those concerned with radiological protection at nuclear power plants (radiation protection managers and staff members, maintenance and operation planners...), contractors, exposed workers (represented by trade unions or work committees), inspectors and other regulatory bodies representatives, and international organisations. The Symposium is also opened to research reactors and professionals from other nuclear fuel cycle installations that have common radiological protection problems with nuclear power plants.



## SYMPOSIUM GOALS

The main aims of the Symposium are:

- to provide a **large forum of information exchange** on occupational exposure concerns (practices, management and procedures, dose results and reduction, improvements of techniques and tools, etc.),
- to allow vendors to present their recent experience and developments in radiation protection (measurement techniques, operating and plant design improvements, ALARA practices during operation and outages, etc.) in a **commercial exhibition**. Vendors will have also the possibility to make oral presentations in plenary session room during coffee-breaks.

The Symposium will give an opportunity for the participants to take part in **discussions in plenary sessions**, and **presentations of posters**. Visits will be organised the last day of the Symposium at Dukovany NPP and Temelin NPP (restricted number of participants).

### LANGUAGE

The working language of the Symposium will be English.

### **CALL FOR PAPERS**

Participants are invited **to propose oral and/or poster presentations** covering all aspects of practical implementation of radiation protection for Occupational Exposure Management at Nuclear Facilities.

Some topics of particular interest have been identified by the Programme Committee:

- Internal Dose Management
- Contamination Management
- Impact of Power Uprate on Dose Rates and Doses
- Use of Dose Constraints

In addition, the following topics are also of interest:

- ALARA Management
- RP Indicators
- RP Management and Organisation
- ALARA Aspects at the Design Stage of Plant Modifications and New Built
- RP at the Decommissioning Stage
- RP and Waste Management
- Source-Term Management
- RP Education and Training
- Work Management Experiences
- Dosimetry and Measurement Materials
- Lessons Learned in RP from Events and from Fukushima Accident

The Symposium will also give the opportunity of the two following ISOE Expert Groups to report and discuss their activities:

- Occupational Radiation Protection in Severe Accident Management and Post-Accident Recovery
- Water Chemistry and Source Term Management

Authors wishing to provide oral and/or poster presentations are invited to submit an abstract or a paper written in English typed single-spaced in Times New Roman 11 pt (Word format). These abstracts/papers should contain the title of the contribution, name(s) of author(s) and institutional address(es), phone / fax numbers and Email address. All abstracts should be sent to the contact-person below by the 15<sup>th</sup> of December 2011 by Email or by fax.
